AN ORDER REORGANIZING THE LOCAL COUNCIL FOR WOMEN IN THE MUNICIPALITY OF CABARROGUIS

WHEREAS, RA No. 9710 "An Act providing for the Magna carta of Women" encourages Local Government Units to organize the Local Council of Women;

WHEREAS, the state shall undertake temporary special measures to accelerate the participation and equitable representation of women in all spheres of society particularly in the decision-making and policy-making processes in government and private entities to fully realize their role as agents and beneficiaries of development;

WHEREAS, the State shall institute the following affirmative action mechanisms so that women can participate meaningfully in the formulation, implementation, and evaluation of policies, plans, and programs for national, regional, and local development;

NOW THEREFORE, I, AVELINO N. AGUSTIN, JR., Municipal Mayor of Cabarroguis, Quirino, by virtue of the powers vested in me by law, do hereby order the reorganization of the Local Council for Women in the Municipality of Cabarroguis.

Section II. Functions/Role of the Council

- 1. Mainstreaming of gender and development in the LGU, and the passage of local legislation addressing gender issues and women's concerns;
- 2. Formulation of the LGUs GAD Plan and Budget;
- 3. Establish linkage with business sector, GO and NGO institutions to enable women's access to resources, information and technology, in order to pursue its projects more effectively;
- 4. Build the entrepreneurial capability of marginalized women locally, nationally and internationally.
