Brief History of the Barangay

Barangay Zamora is a certain of then conflict of the municipalities of Diffun and Aglipay. It was once a part of Barangay Gundaway then of the municipality of Diffun way back the year 1950.

In 1966, Mayor Jose B. Aquino of Aglipay, an Aeronautic Engineer, obtained a Cadastral Map from the Bureau of Lands in Bayombong, Nueva Vizcaya from which he discovered that the southern part of Diffun, that includes Barangay Gundaway, belongs to Aglipay. During that time, Dr. Luis Bergado, the Municipal Mayor of Diffun, was in conflict with incumbent barangay captain Florencio M. Valdez, Sr. of Barangay Gundaway who accused him of playing favoritism in favor of the Barangay Kagawads of the latter.

The Municipal Council of Aglipay claimed those portion but was opposed by the Municipal Council of Diffun. Some dialogues were conducted by both councils to resolve the claims which later on resulted into an agreement to hire the services of a private surveyor to determine the exact boundaries of the said political subdivision with respect to the technical description of the Cadastral Map at hand. Survey results that postion of Barangay Gundaway actually belongs to Aglipay, thus its division.

On June 16, 1966, at the height of the hostility between Barangay Captain Valdez and Mayor Bergado, Mayor Aquino visited his new found land wherein warmly welcomed by the people. In a meeting held he promised to construct an Elementary School and a Municipal Sub-office thereon. This inspired them to sought for the creation of a new barangay apart from Gundaway under the administration of the Municipality of Aglipay, Mayor Aquino headed to their proposal and not long thereafter christened the new regular barangay named ZAMORA, in honor of the late Fr. Jacinto Zamora, one of the three (3) martyr priests executed by the Spanish friars.





But in the creation of the municipality of Cabarroguis on June 21, 1969, Barangay Zamora was separated from Aglipay and became a political subdivision of the newly-created municipality.

Topographically, Zamora is situated at the northern part of Cabarroguis with a land area of more or less one (1) square kilometer comprised of hills and plains suitable for agriculture. It is one of the two (2) determined urban barangays of Cabarroguis comprising the poblacion area with seven (7) Purok. Economically speaking Zamora is one (1) of the largest and richest barangay of Cabarroguis.

At the seat of the municipal government, it hosts the most of national offices situated in the municipality of Cabarroguis such as, the PNP Station, Postal Office, Municipal and Regional Trial Courts, Department of Justice Offices, Land Transportation Office, Bureau of Jail Management and Penology, Bureau of Fire Protection, Zamora Elementary School and Quirino General High School, as well as vital local installation such as, the Municipal Hall Building, the Sangguniang Bayan Office, ABC Hall, Rural Health Unit, Old Cabarroguis Public Market, Cabarroguis Peoples Gymnasium, local churches and sectarian school.

Barangay Zamora has gone far in terms of development and progress through the courageous and dedicated leadership of the following administrators in chronological order – Florencio M. Valdez, Sr., Bonifacio Sotto, James O. Aduca, Leo V. Calauagan, Teresita S. Domingo, William A. Valdez, Reyvirgil R. Domingo, Florencio L. Valdez, Jr. and presently by Hon. Pedro G. Laitan who is now on his third term.

Barangay Zamora has completely transformed into a progressive community as seen in the massive development in infrastructure and economy. Barangay facilities and business establishments mushroomed and road networks tremendously improved. Significantly, it has in its territory the famous Susong Dalaga, a potential tourist destination for nature lovers.

In the pursuit of further development through shared governance and rekindling the tradition of "bayanihan", the people of Zamora established the Panagbibinnulig Festival in 2009 and later on institutionalized as the official annual festival of Barangay Zamora, an annual celebration depicting the





value of cooperation and unity among its citizens towards realization of common objective which made Barangay Zamora famous.

As testament of its feats in governance, Barangay Zamora received numerous awards and recognitions in the year 2018 are: Most Outstanding Barangay Secretary in Region 02, Municipality Category, Best Punong Barangay, Best Barangay Secretary, Best Barangay Council in the provincial and municipal level, Best Punong Barangay, Best Barangay Secretary, Best Barangay Council, Best LTIA Implementer and Best ARTA Implementer through regional level evaluations and several more. The latest of which in Year 2023 the barangay received third place in the Search for Best Barangay in the municipality and Best ECCD Implementer fifth place at the provincial level. This is Barangay Zamora, a Clean and Green Barangay, a peaceful community to live in.

The State of Barangay Governance Report shows that the barangay's overall performance rating is 4 or equivalent to Performance Level of Compliant to the minimum requirements of the 1991 LGC and other Laws; Sustain the good practice in the barangay governance. The area of Financial Accountability should be the top priority for development considering that the remarks is needs major reinforcement and regards to the barangay's complinance to the minimum requirements of the 1991 LGC and other laws; Likewise the area of Agricultural and Fisheries Development and the area of Entrepreneurship, Business and Industry Promotion priority for development considering that the remarks is needs minor reinforcement(s) in regard to the barangay's compliance to the minimum requirements of the 1991 LGC and other Laws. Sustain the good practice in the barangay governance to focus on the service areas of Barangay Legislation, Transparency, Citizens Participation, Revenue Generation, Revenue Allocation and Utilization, Facilities and Customer Service, Health and Nutrition, Education, Culture and Sports, Natural Resource Management and WasteManagement and Poluution Control.

In general, the level of effort which had brought about desirable performance or condition in the areas of Social Services and Environmental Management has to be sustained.

Problematic areas have to be given full consideration. Otherwise, the pace of development and change will be slowed down by the problems. Starting on the ensuing year, the following initiatives shall be pursued.

On Administration

- 1. Focus on the performance of Development Planning, Financial Accountability and Human Resource Management and Development for there are trainings not conducted.
- 2. Sustain the performance on Barangay Legislation, Transparency, Citizen's Participation, Revenue Generation, Revenue Allocation and Utilization, and Facilities and Customer Service,





On Social Services

- 1. Sustained the implementation of "Batas ng Kasambahay" for monthly submission of reports to PESO and DILG.
- 2. The barangay not issued BPO and no cases for children.
- 3. Sustained the performance on Health and Nutrition and Education, Culture and Sports

On Economic Development

- 1. The barangay needs the presence of Agricultural Support Services.
- 2. The barangay must involve in an income and to capacitate residents on how to effectively manage a micro-business enterprise by having a registered Micro-Business Enterprise (BMBE) in the BMBE Registry.





On Environmental Management

1. Despite of one (1) indicator not applicable in the barangay which is Support to Conservation Program still the Barangay complied to the requirements on environmental management for the proper implementation of ordinances, programs and activities through the joint effort of barangay officials, barangay employees, zone leaders, NGO's, CSO's and barangay constituents as well.

On Financial Performance

The CY 2023 Budget amounted to **Php 4,849,813.00.** The expenditure program was distributed as follows:

Among the sectors, Personal Services received the biggest share of 55% of the total budget.

On the other hand, the actual income for Calendar Year 2023 **Php 6,417,402.58** and the total picture of the fund utilization shows that the barangay incurred **Php** ______ expenses of its budget. Overall, it indicates an amount of **Php** ______ savings.

Significantly, the barangay spent its financial resources hugely on personal services of elected and appointed officials and implementation of projects.



The barangay garnered an overall performance rating of 4 or a remarks of compliant to the minimum requirements of the 1991 LGC and other Laws, Sustain the good practice in the barangay governance. Despite overcoming the rigorous processes in the implementation of the different policies and programs in the barangay, there are still several issues/deficiencies which need necessary improvement:

On Administration, where we have nine (9) service areas, it earned an average performance rating of 89% which denotes a performance level of 4. This is attributed to the adherence to the requirements on the service area on Barangay Legislation, Transparency, Citizen's Participation, Development Planning, Revenue Generation, Revenue Allocation and Utilization, Facilities and Customer Service and Human Resource Development and Management. The Barangay shall then sustain its good barangay governance practices on the eight (8) service areas and focus on the service area of Financial Accountability for total compliance in the area of Administration.

On Social Services, we obtained an average rating of 96% which indicates the performance level of 4, Sustain the good practice in the barangay governance. This is credited to the service areas of Health and Nutrition, Education, Culture and Sports, and Public Safety and Disaster Risk Reduction and Management.





On Economic Development, the barangay got an average rating of 55% and a performance level of 3 which points out the presence of Barangay Agricultural Support Services for economic development and sustained effort in achieving a good economic condition in the barangay the key for having a better or improved standard of living to both constituent's and officials. This can be done through establishing livelihood programs, more employment opportunities and other ways of increasing income of the people/constituents for there are some indicators not applicable in the barangay.

On Environmental Management, likewise rated is how the barangay faired in Environmental Management under the Service Areas of Natural Resources Management and Waste Management and Pollution Control where it garnered an average rating of 100% which denotes a performance level of 4. This is attributed to the effort and support of elected and appointive barangay officials, constituents, zone leaders and with the full cooperation of all sectors concerned and complying the programs and activities from higher agencies in sustaining environmental management, it paved the way towards the success of the year under review, CY 2023.



1. Administration

Barangay administration is one of the crucial and essential functions of the barangay. All local government units including the barangay need to undergo self-assessment to measure their performance in terms of delivery of services.

There are nine (9) sub areas which include Local Legislation, Transparency, Citizens' Participation, Development Planning, Revenue Generation, Revenue Allocation and Utilization, Financial Accountability, Facilities and Customer Service, and lastly Human Resource Development and Management.





> BARANGAY LEGISLATION

Legislation is the heart of governance. This is the foundation of effective implementation of laws which leads to a better management and development of the LGU.

One of the basic functions/roles of the Sanggunian is the enactment of ordinances and adoption of resolution. This process is called legislation. In order to formulate responsive ordinances/resolutions, there is a need to have proper structure and processes. A monitoring process is needed in order to check the implementation of ordinances.

Of the nine (9) indicators, Barangay ZAMORA obtained 9/9 indicators.

All of the above indicators complied by the Barangay Officials. The Barangay has formulated and implemented its Internal Rules of Procedures as their guide in conducting sessions to enact ordinances and adopted resolutions. The construction of the session hall/barangay hall was through the donated funds of the former Congressman in the Province while the acquisition of furnitures, fixtures and equipments were from the barangay funds and provincial funds.

Public trust should always be given premium/importance by the barangay officials. It is necessary that their constituents are informed and made aware of the operation of the barangay affairs. This is easily done if the barangay opens in all its transactions and operation to the public.

Of the five (5) indicators, Barangay Zamora satisfied 5/5 indicators.

The Sanggunian enacted a Barangay Tax ordinance as basis in their collection of fees and charges. This was very essential in order to generate revenues that are used to fund programs and projects for the benefit of the barangay. The absence of barangay owned economic enterprise was due to the presence and lot of nearby enterprises. Moreover, the barangay was located in the poblacion area. Likewise fund raising activity conducted for the construction of Barangay People's Park situated at Zamora Elementary School compound.





> REVENUE ALLOCATION AND UTILIZATION

Compliance to mandatory budgetary allocations of barangay ensures that the vital service functions are funded and the priority development concerns of the Barangay are implemented.

Further, actual expenditure figures confirm whether the budgetary appropriation have been disbursed for the intended service functions.

The barangay has two (2) Day Care centers prepared young children for formal elementary schooling and had provided the venue for supplemental feeding for young children enrolled in the said facility.


A Reading Center is provided inside the barangay hall which allowed the constituents to have access to reading materils that will enrich and updates their konwlege.

The barangay has an organized BPOC that handles the community's peace and order situation and formulated its Barangay Public Safety Plan.

The CBDRRM Plan was formulated through the BDRRM Council to handle issues pertaining the disaster management in the barangay. The barangay has a Disaster Operations Center located at the barangay hall compound. It is equipped with disaster equipment, stock pile and other equipments that can be used during disaster. These equipment were purchased by the barangay and others were donated by politicians.

The presence of organized BADAC ensured that the barangay is maintained as a drug-free community through its coordination with concerned agencies.

The barangay implemented KP Law through its constituted Lupong Tagapamayapa that carried out amicable settlement of disputes. Records of cases filed and acted were kept by the Barangay Secretary at the Barangay Office.

The barangay has eight (8) active Barangay Tanods who conducted regular duty and foot Ronda patrol. The team scheduled themselves daily duty at the barangay office and ready to assist on any programs and activities in the barangay. The team sustained safety of residents and peace and order in the barangay. It has a patrol vehicle and the L300 that the team can used in conducting regular patrol.





3 Remonie Development

Good economic condition in the Barangay paves the way for a better or improved standard of living of the constituents. Establishment of livelihood programs, creation of opportunities and other forms of economic activities are contributory to the economic development of the people in the barangay.

The Barangay Officials are committed to address the various needs of the barangay residents. The utilization of this report shall further guide them in focusing the most needed services that will greatly benefit the community.



Section 4. General Provision

Part III. General Provision

- 1. All items of appropriation in this ordinance shall be used only for the purposes for which they are appropriated.
- 2. In the use of savings, priority shall be given to the augmentation of existing but deficient amounts set aside for the payment of compensation, personnel benefits, leave credits.

Savings refer to portions or balances of any release appropriations in this Ordinance free from any obligation or encumbrance, still available after the satisfactory completion or the unavoidable discontinuance or abandonment of work, activity or purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absences without pay.

- 3. The 30% Quick Response Fund (QRF) appropriated under the Barangay Disaster Risk Reduction and Management Fund (BDRRMF) shall be used as standby fund for relief and recovery program. The release and use of QRF shall be supported by a resolution of the Sangguniang Bayan declaring the barangay under the state of calamity or a Presidential declaration of a state of calamity.
- 4. The BDRRMF shall be used in accordance with R.A. No. 10121.
- 5. This Appropriation Ordinance will serve as the release document and all items of appropriation are comprehensively released, provided that if there is a shortfall in revenues, the Punong Barangay is authorized to issue negative Allotment Release Order without need of further action from the Sangguniang Barangay.

Section 5. Separability Clause. If for any reason, any section or provision of this Appropriation Ordinance is disallowed in Budget Review of declared invalid by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

Section 6. Effectivity. The provision of this Appropriation Ordinance shall take effect on January 1, 2023.
