The Barangay achieved an overall performance rating of 88%, indicating compliance with the minimum requirements of the 1991 LGC and other laws, while also sustaining positive practices in barangay governance.

Although successfully navigating the challenging processes of implementing different policies and programs in the barangay, there are still several areas of concern and insufficiencies that require necessary improvement:





In the area of Administration, an average rating of 91% was achieved, demonstrating compliance with the minimum requirements of the 1991 LGC and other laws, while also maintaining good practices in barangay governance. This rating was influenced by factors such as Barangay Legislation, Transparency, Citizen's Participation, Development Planning, Revenue Allocation and Utilization, Financial Accountability, and Human Resources Development.

For Social Services, an average rating of 89% was attained, indicating strong performance and adherence to the minimum requirements of the 1991 LGC and other laws, while also sustaining positive practices in barangay governance. This success can be attributed to areas such as Health Nutrition, Education, Culture, Sports, Women and Children, Public Safety, and Disaster Risk Reduction Management.

In terms of Economic Development, the barangay achieved an average rating of 79%, signifying compliance and showcasing some strengths in Agricultural and Fisheries Development, as well as Entrepreneurship Business & Industry Promotion.

Additionally, the barangay's performance was evaluated in Environmental Management, specifically under the Service Areas of Natural Resources Management and Waste Management and Pollution Control, where it obtained an average rating of 92%. This success can be credited to effective Natural Resources Management and Waste Management and Pollution Control practices.

The cooperation of all sectors involved paved the way for the success achieved during the review year, CY 2023.



### 1. Administration

Barangay administration is one of the crucial and essential functions of the barangay. All local government units including the barangay need to undergo self-assessment to measure their performance in terms of delivery of services.

There are nine (9) sub areas which include Local Legislation, Transparency, Citizens' Participation, Development Planning, Revenue Generation, Revenue Allocation and Utilization, Financial Accountability, Facilities and Customer Service, and lastly Human Resource Development and Management.

#### BARANGAY LEGISLATION

Legislation is the heart of governance. This is the foundation of effective implementation of laws which leads to a better management and development of the LGU.

One of the basic functions/roles of the Sanggunian is the enactment of ordinances and adoption of resolution. This process is called legislation. In order to formulate responsive ordinances/resolutions, there is a need to have proper structure and processes. A monitoring process is needed in order to check the implementation of ordinances.

Of the nine (9) indicators, Barangay Banuar obtained 9 indicators or remarks of 100%. The Sangguniang Barangay through the leadership of Punong Barangay successfully complied the requirements.

The presence and implementation of Internal Rules of Procedures had guided the barangay officials in the proper and orderly conduct of regular sessions. Two (2) regular sessions are conducted monthly as reflected in the minutes of the meetings kept by the Barangay Secretary. Through this, they were able to discuss issues and concerns affecting the community.

The Barangay Hall has its designated Session Hall where the barangay officials conducted their sessions and official functions. It is likewise equipped with individual Sangguniang Barangay member's table which also utilized as their conference table. Chairs and gavel are also present in the session hall.


#### > TRANSPARENCY

The barangay conducted Barangay Assembly Day on June 30, 2022 at the same time held a Turn-Over Ceremony between the Outgoing Punong Barangay Hon. Zernan B. Cariño and Incoming Punong Barangay Hon. Alex D. Tangonan. Hon. Cariño won the position of Sangguniang Bayan Member of the Municipality of Cabarroguis. Hon. Tangonan occupied the Punong Barangay position, as the law mandates that the same position be filled up.

The Semestral Barangay Assembly was conducted on March 21, 2023. It was during this activity that the Sangguniang Barangay Members reported their individual accomplishments based on their committee chairmanship. It is also provided them proper venue to present their plans and activities for the year.

Financial Status was presented by the Barangay Treasurer, this enabled the constituents to know about all revenues collected and funds received. It showed how much and for what specific purposes the barangay officials spent the barangay funds; hence promoting transparency.

The barangay complied with the Full Disclosure Policy where financial documents were posted in conspicuous places in the barangay, particularly in barangay hall.


#### CITIZEN'S PARTICIPATION

5 out of 5 indicators are present or met by the barangay. This was made possible by the effective leadership of the Punong Barangay and its Sangguniang Barangay members to involve the Civil Society Organizations and People's Organization in the planning, implementation and monitoring of different development projects.

The barangay had included the representative of Civil Society Organizations in the barangay as members in the Barangay Development Council, Barangay Disaster Risk Reduction Management Council, Barangay Peace and Order Council and Barangay Council for the Protection of Children. List of members of BBIs and BDC were maintained by the secretary at the barangay hall. This had allowed their participation in barangay development planning and ensured that the projects undertaken by the Barangay-Based Institutions were responsive to the needs of the barangay.

Barangay officials and various sectoral representatives work together to chart the future development of the barangay and address relevant problems and concerns affecting the community. Of the eight (8) indicators, Barangay Banuar met them all. This is equivalent to 100%. Through the continuous strong leadership of the local chief executive and its whole council, the barangay complied this sector. Through Barangay Development Council, it has formulated its development plan which aided the Sanggunian towards setting the economic and social development that benefit largely people including the vulnerable sector that include the disabled, women & children and senior citizens.


The barangay formulated its Annual Investment Program which contained the list of the development projects with corresponding funds for the implementation during the current year.

#### > REVENUE GENERATION

The barangay had an ordinance on tax ordinance which aided the barangay treasurer in proper tax collection.


As shown above, it can be seen that out of 2 indicators, 1 was obtained by the barangay, this is equivalent to 88%.



As shown above, Barangay Banuar failed to comply some of the indicators that resulted 73%. The Sangguniang needs minor reinforcement(s) in regard to the barangay's compliance to the minimum requirements of the 1991 LGC and other Laws to improve this indicator.

The Citizen's Charter is posted in the conspicuous places. This had guided the barangay officials and personnel on the daily operation of barangay. Governance and services are properly handled by the barangay officials.

The presence of other facilities like computer, internet connection and mobile phone contributed the effective and convenient delivery of public services to the barangay residents and provide a proper venue for addressing concerns.

#### HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT

This captures the over-all competency of the barangay officials that run the barangay government. It presents its available human resources (Elective and Appointive) and trainings attended.

Of the above indicators, 3 sub-indicators are failed to obtain that results 82% rating. The barangay has filled up all mandatory appointive positions as compliance to the provisions of the LGC of 1991. The barangay officials and workers attended capacity-building activities which enhanced their skills and knowledge in performing their duties and functions. These enabled them to deliver better public services.

### 2. Social Services

The Barangay, although the smallest political unit, plays a very important role in the delivery of basic services to its constituents as provided for in the Local Government Code. There are three services under this performance area that determines if the barangay's program, project and activities are in harmony with the LGC. The 3 service areas are Health and Nutrition, Education, Culture and Sports and Peace, Security and Disaster Preparedness.

#### HEALTH AND NUTRITION

Health is wealth. This is the reason why most officials prioritize health and nutrition services. Although higher LGUs, such as the province and municipality, provide health and nutrition services, the barangay is mandated to deliver basic health and nutrition services to its constituents.

The above indicators are all present or met by the barangay except the sub-indicator Botika ng Barangay. This is equivalent to 95%. The attainment of such rating can be attributed to the operation of barangay health station that catered to the nutritional and well-being of the constituents. This is complemented with the presence of a midwife and barangay health workers at the health center. The BHW and BNS are likewise stationed at the health center to provide health services to the barangay residents. Through proper coordination with the main Rural Health Unit, various health programs and activities were implemented in the barangay to address health concerns of the constituents.

#### **EDUCATION, CULTURE AND SPORTS**

Another responsibility objective of the barangay is to deliver programs and projects geared toward mental and physical development of both children and adult, such as programs on sports and enrichment of culture and other modes of accessing/enriching knowledge and information.

Of the 8 indicators, barangay rates 86%. The barangay has an organized BPOC and BADAC to handle community's peace and order situation.

The BDRRM plan was formulated by its BDRRM Committee that was also organized, they are involved in handling issues pertaining to disaster management in the barangay.

The barangay implemented KP Law through its constituted Lupong Tagapamayapa that carried out amicable settlement of disputes. Records of cases filed and referred to higher authorities were kept by the barangay secretary at the barangay hall.

Barangay Banuar has 5 active Barangay Tanods who conducted ronda or foot patrol every Sunday. The team sustained safety of residents and peace and order in the barangay. They has a patrol tricycle that being used in conducting their patrol.

### 3.Economic Development

Good economic condition in the Barangay paves the way for a better or improved standard of living of the constituents. Establishment of livelihood programs, creation of opportunities and other forms of economic activities are contributory to the economic development of the people in the barangay.





Based on the indicators contained in the data capture form of the BGPMS, the following are the gathered data





It is a self-assessment tool to measure the capabilities and limitations of the barangay in the delivery of essential public service to the people. Result of this report shall serve as the guiding reference in addressing people's concern along the four (4) Perfomance Areas: Administration, Social Services, Economic Development and Environmental Management with the corresponding seventeen (17) service areas.

With the attainment of Performance Index of 4, the barangay is compliant to the minimum requirements of 1991 LGC and other laws. The barangay must likewise sustain the good practice in the barangay governance.

Specifically, the barangay obtained a Performance Level of 4 in performance areas Administration. This was represented by color code green based on the BGPMS Scoresheet. Its compliance to the indicators per service area needs to be sustained. However, there is a need for the barangay officials to take into consideration the compliance to the other requirements of the law that were not met under there areas during the year.

The barangay must likewise sustain the good practices. The barangay officials shall focus on the Entrepreneurship, Business and Industry Promotion to provide livelihood programs that will promote industry among the residents thereby improving family income of the same time. While Barangay Officials are committed to address the various needs of the barangay residents, the utilization of this report shall further guide them in focusing the most needed services that will greatly benefit the community.













# MAP OF THE BARANGAY






