Brief History of the Barangay

San Marcos was formerly named Cannuangan. At first, it was just a sitio of Cajel, Diffun, Nueva Vizcaya. The name originated from the first settlers of this place who claimed to have constantly heard many carabaos running to and from the place, hence the name Cannuangan, meaning a place with many carabaos.

In 1936, among the first settlers of this place were Pantaleon Ruiz, Santiago Rasalan, Angel Anunsacion, Leon Pagarigan, Feliciano Malaque, Severio Abenoja, Anaclito Abenoja, Domingo Mauyao and Amado Fabros Abenoja the donor of the present School Site of San Marcos Elementary School.

The coming of the Japanese soldier prompted the first settlers to abandon this place, but when the Americans came in 1945, they returned and cleared the still virgin lads. The settlers delegated authority to some leaders who took turns in acting as their temporary heads, among whom were Feliciano Malaque, Domingo and Marcos Mauyao.

With the election of Hon. Silverio Pascua as the first Municipal Mayor of Diffun, Nueva Vizcaya, he designed Amado F. Abenoja as the first Tenyente Del Barrio of Cannuangan. Among the many good things accomplished during the term of Amado F. Abenoja was the changing of cannuangan to San Marcos. The name San Marcos was derived from a very good leader who passed away ahead of the pioneers. Marcos Mauyao, jokingly perhaps because the late Marcos Mauyao was a very religious man, they gave the title san to Marcos, thus San Marcos was born. A resolution to that effect was passed and was approved by the Mayor Silverio Pascua an education was already a primary concern at that time in many new barabgay. The Tenyente del Barrio felt the need, so then Amado F. Abenoja donated one hectareof his acquired lands as the Primary School of San Marcoswhich was erected in 1956 and in the following year, it was opened with Mrs. Manuela Saguise Pimentel, wife of the former Gov. Mariano Pimentel as the first teacher of Grade 1&2 At present the school has complete elementary grades from 1 to 6 and presently accepting Kindergarden pre-school 1&2.






II. Executive Summary

The area of Economic Development and Administration should be the top priority for development considering that the remarks are Compliant to tocus on the service areas of Agriculture, Fisheries Development, Entrepreneurship, Business, Indulty Promotion and Reveneu, Generation.

In general, the level of effort which had brought about desirable performance or condition in the areas of Social Service and Environmental Management has to be sustained.

Problematic areas have to be given full consideration, Otherwise, the pace of development and change will be slowed down by the problems. Starting on the ensuing year, the following initiatives shall be pursued.

On Administration


- The Sanguniang Barangay must have to sustain what have been gained and established and institute measures to address the Problematic one.







The barangay garnered an overall performance rating of 87% or remarks of Compliant to the minimum requirments of the 1991 LGC other laws. Despite overcoming the rigorous processes in the implementation of the different policies and programs in the

Barangay, there are still several issues/deficiencies which need necessary improvement:

On Administration, where we have nine (9) service areas, it earned an average performance rating of 97% which denotes to sustain the good practice in the barangay. This is attributed to the strict implementation and adherence to all requirments, guidelines and or mandates governing the service area:

On Social Services, we obtained an average rating of 84% which indicates to sustain the good practice in the barangay. This is credited to the provisions of almost all the needed requirments and diligent exircise of duties and function of concerned employees.


On Economic Development, the barangay got an average rating of 68% or which points out that the barangay needs to promote livelihood projects and program.

Also rated is how the barangay fared in Environmental Management under the Service Areas of Natural Resources Management and Waste Management and Pollution Control where it gamered an average rating of 100% This is attributed to the strict implementation of solid waste ordinance focusing on waste segregation and regular hauling of garbages.

With the full cooperation of all sectors concerned, it paved the way towards the success of the year under review, CY 2023.

Barangay administration is one of the crucial and essential functions of the barangay. All local government units including the barangay need to undergo self-assessment to measure their performance in terms of delivery of services.




> LOCAL LEGISLATION

> TRANSPARENCY



- HEALTH AND NUTRITION






VI. Alternative Courses of Action
