AN ORDER ORGANIZING THE PLANNING, MONITORING AND EVALUATION TEAM FOR THE CREATION OF THE LOCAL INVESTMENT PLAN FOR HEALTH AND ANNUAL OPERATIONAL PLAN IN THE MUNICIPALITY OF CABARROGUIS, QUIRINO

WHEREAS,

Department of Health (DOH) Administrative Order No. 2018-0014 dated May 21, 2018 provides guidelines on the Development of Local Investment Plans for Health which ensures its promotion and implementation of health programs, projects and activities in the municipality;

WHEREAS, pursuant to said Order, the Local Investment Plan for Health (LIPH) refers to a medium term public investment plan for health that specifies the strategic direction of the concerned LGU for the next three years in terms of improving health service delivery, strengthening the health systems operations and addressing social determinants of health, and specifies actions and commitments of different local stakeholders;

WHEREAS, the LIPH shall maximize local and national resources towards the development of a responsive local health system;

WHEREAS, there is a need to organize the LIPH Team to assist the Rural Health Unit in the preparation of the Local Investment Plan for Health and ensure its integration in the development planning in the LGU.

NOW THEREFORE, I, AVELINO N. AGUSTIN, JR., Municipal Mayor by the virtue of the powers vested in me by law do hereby order the creation of the Local Investment Plan for Health Planning Team for the Municipality of Cabarroguis, Quirino with the following composition and functions;

SECTION 1. COMPOSITION. The planning, monitoring and evaluation team for the Local Investment Plan for Health shall composed of the following:

SECTION II: FUNCTIONS AND RESPONSIBILITIES. The Local Investment Planning, Monitoring and Evaluation Team shall perform the following functions:

1. Develop/formulate the LIPH reflecting the health programs, plans and activities of the municipality based on the current thrust of the National Government, which must be translated into three (3) Annual Operational Plans (AOP);
2. Facilitate the implementation of the AOP's or the PPA's identified in the LIPH, which shall be aligned with the municipality's Local Development Investment Plan (LDIP) and Comprehensive Development Plan (CDP) to ensure budget allocation;
3. Ensure participation of Civic Society (CSO's) private health sector stakeholder in both planning process and implementation of LIPS;
4. Monitor and evaluate the implementation of LIPH and AOP;
5. Convene quarterly regular meeting of the team, or as the need arises;
6. Ensure timely submission of consolidated LIPH based on agreed timelines;
7. Perform other functions as may be necessary to ensure the functionality of the team and to ensure the development, implementation, monitoring and evaluation of the Local Investment Plans for Health of the Municipality;

SECTION III: DESIGNATION OF FOCAL PERSON. The Municipal Health Officer, ELIZABETH A. CAMELLO, MD, MPH, MHA assisted by MAUREEN GRACE D. RIVERA, Nurse I, is hereby designated as the Focal Person of the Local Investment Plan for Health Planning Team to ensure compliance of his order.

SECTION IV. EFFECTIVE. This order shall take effect immediately.
