“AN EXECUTIVE ORDER CREATING MUNICIPAL INTER AGENCY COMMITTEE (MIAC) IN THE MUNICIPALITY OF CABARROGUIS, QUIRINO”

WHEREAS, The Local Government are mandated by the Local Government Code of 1991 otherwise known as R.A 7160 to exercise powers that are essential to promote the general Welfare;

WHEREAS, the rudimentary program of DSWDO is poverty alleviation commonly shared by the PantawidPamilyang Pilipino Program (4PS). Sustainable Livelihood Program (SLP) and the Kapit-Bisig Laban saKahirapan Comprehensive and Integrated Delivery (KALAHYON-CIDSS);

WHEREAS, the Municipality of Cabarroguis is a recipient of the Kapit-Bisig Laban saKahirapan Comprehensive and Integrated Delivery of Social Services National Community-Driven Development Program (KALAHYON-CIDSS-NCDDP) of the Department of Social Welfare and Development (DSWD);

WHEREAS, the creation of the Municipal Inter-agency Committee (MIAC) is essential in Carrying out the effective implementation of the program.

Section I. COMPOSITION

NOW THEREFORE, I, AVELINO N. AGUSTIN, JR., Municipal Mayor of the Municipality of Cabarroguis, by power vested in me by law, do hereby order the creation of the Municipal Inter-Agency Committee (MIAC), with the following composition to wit:

Section II. FUNCTIONS

The Municipal Inter-Agency Committee shall perform the following functions:

1. Coordinate the programs and projects of the various member agencies to effectively implement the KALAHY-CIDSS-NCDDP Program.
2. Initiate mechanisms and venue to maximize the involvement of all member agencies in the Local Government Unit.
3. Build convergence of programs and interventions during the process of implementation of program.
4. Provide relevant data to the Barangays to facilitate needs assessment and analysis and to provide technical assistance in the implementation of the barangays sub-projects.
5. Promulgate regulations as maybe necessary for the effective implementation of the program.
6. Monitor and oversee the strict implementation of the program.
7. Direct other agencies to respond to the issue and concerns during the implementation of the program.

Section III. ACCOUNTABILITY AND REPORTING

The MIAC shall ensure that appropriate reports and other project documents be provided to the Municipal Mayor and the Committee.

Section IV. EFFECTIVITY

The Order takes effect upon its approval.
