AN ORDER ORGANIZING THE ANTI-DENGUE TASK FORCE IN THE MUNICIPALITY OF CABARROGUIS

WHEREAS, the local government units are mandated under the Local Government Code to promote health and safety for its constituents by providing measures to prevent and control the spread of diseases, particularly dengue, and provide assistance to those afflicted;

WHEREAS, dengue has become a major public health concern in the country and in some parts of the world;

WHEREAS, environmental sanitation is still the most effective way in the elimination and ultimate destruction of breeding sites of the mosquito vector carrying the disease

WHEREAS, given the preventability of the disease, it is prudent to provide for a community-based dengue prevention and control mechanism, and strengthen existing policies implemented by the Department of Health (DOH);

NOW THEREFORE, I, AVELINO N. AGUSTIN, JR., Municipal Mayor of Municipality of Cabarroguis, Quirino by virtue of the powers vested in me by law, do hereby order the organization of an Anti-Dengue Task Force in the Municipality of Cabarroguis.


