AN ORDER REORGANIZING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC)

WHEREAS, Republic Act No. 10121 otherwise known as the “Philippine Disaster Risk Reduction and Management Act of 2010”, was enacted to strengthen the Philippine Disaster Risk Reduction System;

WHEREAS, such law provides for the development of policies and plans and the implementation of actions and measures concerning all aspects of disaster risk reduction and management and early warning knowledge-building and awareness-raising, reducing underlying risk factors and preparedness for effective response and early recovery;

WHEREAS, it is further provided that all Local Government Units shall establish/organize their own Municipal Disaster Risk Reduction and Management Council (MDRRMC);

NOW THEREFORE, I, WILLARD V. ABUAN, Municipal Mayor of the Municipality of Cabarroguis, by virtue of the powers vested in me by law, do hereby order the re-organization of the Municipal Disaster Risk Reduction and Management Council (MDRRMC).

SECTION II. FUNCTIONS:

1. Approve, monitor and evaluate the implementation of the Local Disaster Risk Reduction and Management Plan and annually review, test develop the plan consistent with other national and local planning programs;
2. Ensure the integration of disaster risk reduction and climate change adaption into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;
3. Recommend the implementation of forced or preemptive evacuation of local residents, if necessary; and
4. Convene once every three (3) months, or as necessary to effectively coordinate the efforts on disaster prevention and mitigation, preparedness, response and/or emergency operations, recovery and rehabilitation activities.
5. Take the lead in preparing for responding to and recovering from the effects of any disaster and emergencies; and
6. Discharge such other directly related to its mandate, in consonance with the provisions of R.A No. 10121 and its implementing Rules and Regulations.

This Executive Order supersedes Executive Orders, Memoranda and Issuances previously issued.
